

1. Introduction

Introduction to a SSAS loan application for a commercial property purchase. To apply for a loan you must have a self-administered scheme (SSAS).

Loan application process

Initial stage - we recommend that you discuss your goals with a regulated financial adviser to asses the suitability of purchasing a commercial property through a SSAS.

Property selection - identify the commercial property that you wish to purchase.

Loan application - complete the loan application and return it to iPensions Group along with a copy of the RICS valuation report. The report must include the current market value of the security property and any properties held in the pension scheme. In addition, the report should be addressed to the Trustees of the pension scheme.

Approval - upon approval of the loan this will be issued to facilitate the property purchase.

Ongoing management - the property will be managed as part of the pension scheme.
